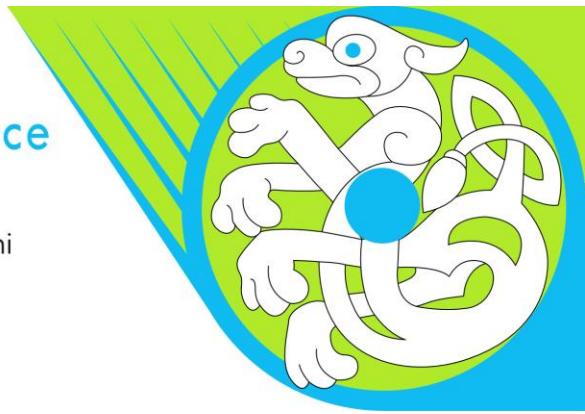

DEBIT ORDER INSTRUCTION

1. The Signatory authorises Animal Health and Hydro Fourways (PTY) LTD to debit the nominated bank account, with banking details stipulated above.
2. The Signatory hereby authorises Animal Health and Hydro Fourways (PTY) LTD to issue and deliver payment instructions to its banker for collection against the abovementioned account on condition that the sum of such payment instructions will never exceed the Signatory(ie)'s obligations under this agreement.
3. The Signatory agrees that in such case that the selected debit date is a public holiday, the debit will automatically be processed on the next working day.
4. The Signatory agrees that Animal Health and Hydro Fourways (PTY) LTD is entitled to debit the nominated bank account, at whatever bank that account is held, with all fees or amounts lawfully owing in terms of this Agreement.
5. The Signatory agree to notify Animal Health and Hydro Fourways (PTY) LTD immediately in writing if any of these bank account details changes, and failure to do so will be a material breach of this Agreement.
6. The Signatory is/are responsible for all banking costs in respect of all amounts payable.
7. The Signatory will pay the administration fee, for each payment due by the Signatory to Animal Health and Hydro Fourways (PTY) LTD which is returned unpaid by the nominated bank.
8. The Signatory agree that although this authority and mandate may be cancelled by him/her, such cancellation will not cancel this Agreement.
9. The Signatory authorises Animal Health and Hydro Fourways (PTY) LTD to notify the national credit bureaus of any missed or late payments and to list a default in the name of the signatory in the event the signatory is 90 days or more in arrears.

POPIA CONSENT

Section 11 of the Protection of Personal Information Act 4 of 2013 (POPIA) provides for the lawful and necessary processing of a data subject's personal information with its, his or her consent and section 10 of POPIA qualifies this by stipulating that "personal information may only be processed if, given the purpose for which it is processed, it is adequate, relevant and not excessive. Animal Health and Hydro collects and processes personal information of applicants who are using Animal Health and Hydro's services. Accordingly, your personal information (being the person/s signing this form) will be collected and used to verify your identity, credit status, ownership of your bank account etc. in order to enable you to pay for the services rendered by Animal Health and Hydro over the mutually agreed upon number of instalments. In addition, such personal information will be kept confidential and stored in a secure manner until such time when the applicant terminates its agreement after fulfilling the payment obligations to Animal Health and Hydro for serviced rendered by Animal Health and Hydro, whereafter such personal information will be held securely for a period as stipulated by applicable legislation. Upon expiry of such period the personal information will either at your request be returned to you or, if Animal Health and Hydro receives no such request within a reasonable time, be destroyed. The personal information will not be used for marketing, or any other purpose other than as stated above or as otherwise consented by you or allowed by law. By ticking this box, I/We the undersigned give my/our consent for Animal Health and Hydro to process the personal information as stipulated above.

By ticking this box, I/We the undersigned grant permission to Animal Health and Hydro

to report my/our payment history, including late payments or missed payments, to national credit bureaus such as but not limited to: ITC, Experion etc., This includes reporting your name, identification number, account details, payment history, and outstanding balance. You have the right to dispute any inaccurate information reported to credit bureaus and can request a copy of your credit report from the credit bureaus. Late payments may result in late fees and may negatively impact your credit score. Reporting will occur quarterly, and you will be notified when your credit information is being reported."
